1. Recycling rebate will be issued upon receipt and processing of the used equipment unit at the Panasonic recycling facility.
2. Recycling Rebate claim form & proof of sales (customer invoice and/or customer receipt) must be received by Panasonic within 30 days of the end user's purchase of a new Panasonic Scanner.
3. Program available to Panasonic Tier A, B, C, & D resellers.
4. All Rebate application forms must include proof of end user purchase (Customer invoice and/or customer receipt).
5. All rebates will be processed by Panasonic.
6. A separate claim form must be completed for each customer claim.
7. Please allow 7 to 10 business days for initial claim approval and shipping label.
8. Rebate checks will be issued to the reseller within 45 days of receipt of the used equipment.
9. Recycling rebate not valid on refurbished or demo units.
10. Authorized resellers must purchase the equipment from a Panasonic authorized distributor to qualify for rebate and proof of purchase must be available upon request.
11. Claims for 10 or more scanners, please contact a Panasonic Scanner Partner Sales Manager for processing & scheduled pickup.
12. A new Panasonic Scanner must be purchased between the dates of April 1, 2020 through March 31, 2021.
13. Program valid in the 48 contiguous United States and excludes Alaska, Hawaii, Puerto Rico, Canada and Latin America.
14. All sales prior to the program start date are excluded.
15. Panasonic reserves the right to audit all claims.

- Upon approval Panasonic will email the prepaid shipping label(s) within 5 business days
- Box up the old scanner and ship it to the Panasonic recycling facility using the prepaid UPS shipping label(s)
- Upon receipt of the old equipment Panasonic will recycle and send the rebate check

For larger projects where freight pickup is necessary, please contact your Panasonic Partner Sales Manager to coordinate claiming & on-site pickup.
